(ii) Such an appeal shall be entertained, only if the candidate produces a medical certificate from a Government/Private doctor of the Speciality/Specialities in which the candidate has been found Unfit Such certificate should contain a note that "The Government/Private Specialist is fully aware of the physical and visual standards set by the Railways for the particular medical category and that he/she is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by an appropriate medical board comprising of three Senior Railway Doctors appointed by the Government in this regard".

The certificate should bear the photograph and marks of identifications of the candidate duly attested by such a Government/Private issuing authority. Such an issuing authority shall also clearly mention his/her full name, designation, address etc. and his/her Medical Council of India/State registration number.
